Bakson Homoeopathic Medical College, plot no. 36-B, Knowlegde Park Phase-1, Uttar Pradesh, Greater Noida is functional since 2002 and has applied for permission for sanction of UG (BHMS) course with 100 UG seats and 42 seats for PG course in 07 subjects with 6 seats in Homoeopathic Philosophy, 06 seats in Materia Medica, 6 seats in Repertory, 6 seats in Homoeopathic Pharmacy, 6 seats in Practice of Medicine, 06 seats in Pediatrics, 06 seats in Psychiatry for the academic year 2024-2025. The college has submitted the Part I information in which the entire functional profile has been narrated. Medical Assessment and Rating Board has examined the profile of the college as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under the NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls as per MSR requirements:

- Form-16 of teaching faculties shall be provided for Dr. Ruby Chaudhary and Dr. Trilok Chand from the traces portal for verification.
- Manual IPD register is not maintained/ uploaded. The same may be sent for verification.
- IPD and OPD case records should be maintained with demographic details of the patient such as Name, Age, Sex, Address, Phone number. All follow up attendance should be recorded on the case records. Case sheets shall be maintained with complete case history, analysis and evaluation and repertorisation and made available in Medical Record Room for academic purpose of students and follow up of patients.

Considering the above observations and facilities available, Medical assessment and Rating board has decided to issue **Conditional permission to Bakson Homoeopathic Medical College, plot no. 36-B, Knowlegde Park Phase-1, Uttar Pradesh, Greater Noida-201310 for conducting UG (BHMS) course with 100 UG seats and 42 seats for PG course in 07 subjects with 6 seats in**

Homoeopathic Philosophy, 06 seats in Materia Medica, 6 seats in Repertory, 6 seats in Homoeopathic Pharmacy, 6 seats in Practice of Medicine, 06 seats in Pediatrics, 06 seats in Psychiatry for the academic year 2024-2025.


All deficiencies noticed shall be rectified within a period of one month and compliance report shall be submitted for verification.

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the permitted intake capacity of 100 UG and 42 PG seats shall be treated as All India Quota. The counseling for seats under All India Quota shall be conducted by respective Counseling authority of State/UT Govt as designated by Central Government/NCH and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.
